#### **ABOUT US**

The CBPBA is a cooperative of landowners and interested parties in 12 Coastal Bend Counties, including Aransas, Bee, Calhoun, DeWitt, Goliad, Jackson, Karnes, Live Oak, Nueces, Refugio, San Patricio, and Victoria. Additional counties may be added in the future. Members share manpower and resources to help each other burn on their properties. The Association has a burn trailer available for rent at a very nominal fee that includes most of the equipment needed to conduct safe burns, including radios, drip torches, and fire suppression equipment.

#### **WHY BURN?**

Prescribed burning is one of the most effective and economical methods of brush management and wildlife habitat enhancement available to landowners. Many plants in Texas are highly burn adapted and respond very positively to burning. Burning was nature's way of maintaining a healthy and dynamic environment until man decided fire was bad. Reduced wild fires have produced uncontrolled brush expansion, degraded wildlife and livestock habitat, and reduced the quantity of useful forage available to wildlife and domestic animals.

Prescribed burning is a safe and economical habitat management tool when applied by knowledgeable people. CBPBA provides prescribed burn training opportunities and encourages the safe use of fire in the Texas Coastal Bend.

If you are interested in increasing the carrying capacity of your range land, or in improving your habitat for enhanced game management, you need to consider initiating a prescribed burn program on your property. It is the least expensive management tool available and can be very effective.

**ABOUT THE U.S. FIRE LEARNING NETWORK**

The USFLN is a joint project of The Nature Conservancy's Global Fire Initiative, the USDA Forest Service and the US Department of the Interior.

In the United States and many other parts of the world, fires are behaving differently now than they have throughout history, largely as a result of human actions. An estimated 80% of U.S. forests and rangelands have altered fire dynamics. The U.S. Fire Learning Network (USFLN) is engaging dozens of multi-agency, community-based projects in a process that accelerates the restoration of landscapes that depend on fire to sustain native plants and animals. By restoring this balance, the ecological, economic and social values of the landscapes can be maintained, and the threat of catastrophic wildfire can be reduced.

**Goal**

By fostering innovation and transferring lessons learned to other landscape projects, scientists and decision makers, the U.S. Fire Learning Network will accelerate the implementation of ecologically based and culturally acceptable fuels reduction and fire regime restoration strategies at ecologically meaningful scales and in high-priority habitats and landscapes.

**Overview**

Network projects cover more than 76 million acres. Operating at local, regional and national levels, the U.S. Fire Learning Network seeks to overcome barriers to implementing ecologically appropriate fuels reduction and restoration projects using a four step process (details here:

The Network presently comprises eight regional networks:

- Appalachian
- California Klamath-Siskiyou
- Centennial
- Florida-Caribbean Fire & Invasives
- Great Plains (*The Refugio-Goliad Prairie is a Demonstration Landscape*)
- Northwest
- South Central
- Southern Blue Ridge

There are also several demonstration landscapes, most of which are embedded within regional networks where they are demonstrating best practices for collaboration and restoration, and actively sharing what they are learning.

**NEED HELP BURNING?**

One CBPBA purpose is to provide reciprocal labor among members. One way for you to get help with your burns is to participate in the burns of other members so they will want to reciprocate. You should also attend CBPBA burn schools





and meetings and “meet and greet” other participants and offer your services.

In order to help with a burn you obviously have to know about it far enough in advance to plan for it. Communicating this information has been a major problem for us in the past. Consequently, we have included a “Burn Pending” communication tool in the new website.

The Burn Scheduling Calendar is located in the website at this URL: [http://www.prescribedburn.org/burn\\_scheduling\\_calendar/](http://www.prescribedburn.org/burn_scheduling_calendar/). You can check it for scheduled burns during the winter and summer burn seasons, and you can have your own burns posted. The following explanation on how to use the Calendar is posted with the calendar and is also included here:

*“This calendar provides a place to list or find information about planned prescribed burns in the Texas Coastal Bend. To have your burn posted email the information (your name, ranch name, burn location, date & time of burn, your contact phone number, and a request for assistance if you want help) to [webmaster@prescribedburn.org](mailto:webmaster@prescribedburn.org). Allow at least 2 to 3 days for us to post it to the calendar, but remember that the earlier the information is listed the more likely it is to be seen.”*

Obviously, the success of this tool is dependent on it being used by our members. We hope YOU make use of it.

### **THE NATURE CONSERVANCY REPORT, WINTER 2010**

The Nature Conservancy’s Prescribed Fire Module in Victoria is expecting a very productive winter burn season. Thanks to Clifford Carter we have nearly 13,000 priority acres to burn. One burn unit spans 3,600 acres of good condition prairie. This block is close to the Attwater prairie chicken release site and is often frequented by chicken’s wearing radio-telemetry transmitters. It’s great to be able to burn existing prairie that has not seen fire in some time so we don’t lose it to brush. There are approximately 40 radio-marked prairie chickens surviving on the Refugio-Goliad, and several of those are from the original release in 2007.

We just completed a burn plan for a 500 acre unit south of Seadrift in critical whooping crane habitat, and have nearly completed all the administrative requirements to light the fire. Due to the prolonged drought the whooper’s left their wintering grounds on the Gulf Coast in 2009 in poor condition. They are now back in the Gulf Coast from their Canadian nesting grounds but are still not in good condition. Opening up foraging habitat for the birds is a high priority for The Nature Conservancy and US Fish and Wildlife Service. Weather permitting, we will implement the burn the week of January 18<sup>th</sup> and it would be a great one to view from a boat. It is on a spoil island directly across the ICWW from Charlie’s Bait Camp. Give Ray Guse a call for information or watch the CBPBA Burn Calendar.

Once again, in mid-February, The Nature Conservancy will host a Prescribed Fire Training Exchange. We will have 20 fire practitioners from around the country working on their qualifications for Burn Boss, Firing Boss, Engine Boss, Advanced Fire Fighter and Fire Effects Monitor. These exchanges have proven to be very valuable for a number of reasons. They give us additional people to implement larger and more challenging burns, and we are able to provide lessons on the local ecological and economic benefits of prescribed fire. The visiting trainees leave the Gulf Coast with a new appreciation for the importance of private lands burning, interact and share knowledge with other fire professionals around the country, and build a broader understanding of the role of fire throughout the United States.

We hope that everyone is able to get their fire guards installed for the winter season because it looks like there is more rain coming and good fire guards may



be the limiting factor in what we believe will be a great season. Remember that there are two caches of equipment available for landowners to check out at The Nature Conservancy's office in Victoria for a very nominal fee. Call Ray to get more information.

**CBPBA GUIDELINES**

Dues - \$25.00 per year. Income will purchase, repair, and maintain equipment and support activities such as meetings, newsletters and correspondence.

Fire Training Education - The Association shall conduct or sponsor one burn school each year. Members should attend a burn school to learn the basics of prescribed fire and receive training on how to operate equipment.

Fire Plans - Prescribed fires will have burn plans prepared by the rancher and reviewed by either the local NRCS office or the CBPBA prior to the burn.

Personnel - A critical number of trained personnel will be determined for each burn. The number will depend on the size and complexity of the prescribed burn as described in the prescribed burn plan.

Liability - Each rancher will be liable for fires on their property. Proof of insurance is required before CBPBA will assist in a burn and such proof should be submitted with the rancher's burn plan.

Fire Lines - Each landowner is responsible for preparing their own fire lines. Fire lines are subject to inspection before the initiation of the prescribed fire and should meet specifications outlined in the burn plan.

Equipment - Use of CBPBA equipment shall be available to all association members at the rate of \$50 for 24 hours or \$75 for 36 hours. A check out/check in form will be completed for each use to document the condition of the equipment and to determine the rate charged. Members are responsible for any damage to the trailer and equipment. Proof of liability insurance on the towing vehicle is required to check out equipment. The Trailer will be available for use by qualified persons who are not members on the CBPBA.

Fire Boss - Each rancher will be the fire boss on their own property unless other arrangements are made.

Participation - Members are encouraged to help on as many burns as possible. Participation provides members with fire-line experience, helps them become acquainted with other members with the same goals and objectives, and builds an experienced team. Participation is recorded for each burn. Ranchers must assist in at least two burns for other members before CBPBA will assist them on their land. Exceptions are made for members not physically able to actively participate on burns. Participation sheets will be available at all burns and completed forms kept on file with CBPBA.
